

INVITATION TO BID
CITY OF OREGON CITY

MAIN STREET ADA IMPROVEMENTS (CI 22-013)

Sealed bids for furnishing all materials, equipment, labor, and services for the construction of the **Main Street ADA Improvements Project (CI 22-013)** for the City of Oregon City (City), Oregon will be received by Sang Pau, Project Manager, 13895 Fir Street, Oregon City, Oregon until **2:00 PM local time on July 6, 2023**. Bids received after this time will not be considered. All bids received prior to the due date and time will be publicly opened and read on the due date and time at the Oregon City Engineering and Operations Center.

The project includes:

- Provide temporary traffic control for all work zones.
- Remove approximately 380 linear feet of concrete curbs, approximately 255 square yards of concrete sidewalk and approximately 400 square yards of asphalt pavement.
- Construct approximately 160 linear feet of storm sewer piping of various sizes and with various backfill, install 7 new storm inlets and one new storm manhole.
- Construct approximately 220 square yards of asphalt roadway restorations.
- Construct approximately 620 linear feet of concrete curb and gutter and approximately 3,400 square feet of concrete sidewalk.
- Restore roadway signing and permanent pavement markings.
- Perform additional and incidental Work as called for by the Specifications and Plans.
- Coordinate work with proposed utility pole relocation by franchise utility companies.

Solicitation documents may be obtained by creating a new user account and registering for the project. General information including the planholder list is available to the public without registering.

Solicitation documents are also available for review at the Oregon City Engineering and Operations Center, 13895 Fir Street, Oregon City, Oregon, 97045 (Telephone: 971-204-4601), between the hours of 8:00 a.m. and 4:00 p.m., Monday through Friday, except legal holidays.

Addenda, clarifications, and notices will be distributed through the City's online planholder system. Potential bidders are responsible for ensuring that contact information is registered correctly and that email updates are being received and not being sent to spam folders. It is in the best interest of potential bidders to check the website periodically to ensure all updates are received. The City is not responsible for failure of bidders to receive notifications of changes or corrections made by the City and posted as stated above.

No bid will be received or considered unless the bid contains a statement by the bidder, as part of their bid, that the provisions of ORS 279C.840 or 40 U.S.C. 276a shall be complied with, a statement as to resident bidder status, and whether the bidder is licensed under ORS 468A.720 (no asbestos removal is contemplated for this project). Prior to submission of its bid, the bidder

shall be registered with the Oregon Construction Contractor's Board, and thereafter comply with the requirements of ORS 701.005 to 701.137.

Each proposal must be submitted on forms prescribed by the City and accompanied by a certified check, cashier's check, or bid bond in an amount equal to 10 percent (10%) of the total amount bid. The successful bidder will be required to furnish a faithful performance bond and a labor and material payment bond each in the amount of one hundred percent (100%) of the amount of contract. The successful bidder will also be required to furnish a statutory public works bond in the amount of thirty thousand dollars (\$30,000.00). Evidence of workers' compensation insurance will be required before the work shall commence.

The City will investigate and determine the qualifications of the apparent low bidder prior to awarding the contract. The City reserves the right to reject any bid not in compliance with all prescribed public bidding procedures and requirements, and may reject all bids if it is in the public interest to do so.

This project is funded by the HUD CDBG (Community Development Block Grant). Contractors must agree to comply with all applicable requirements.

Contractor shall fully comply with ORS 279C.800 through 279C.870, and the Davis Bacon Act, concerning payment of not less than prevailing wage rates; each worker in each trade or occupation employed in the performance of the Work under these Contract Documents, either by Contractor, Subcontractor, or other person doing or contracting to do the whole or any part of the Work, shall be paid not less than the applicable prevailing wage rates for state and federal wages, whichever is higher. Prevailing wage publications applicable to this contract are the Prevailing Wage Rates for Public Works Contracts in Oregon Effective July 1, 2022.
